**Discussion Notes:**

Miller commenced the meeting by welcoming CLC Moroz. She then reviewed the meeting agenda, which was focused on providing an update on Toronto Community BBQ planning. She shared a land acknowledgement, followed by a Safety Moment.

Miller noted that the meeting was called earlier in the month as the planned September 21<sup>st</sup> meeting would conflict with the BBQ. She recognized that not everyone was able to attend the earlier meeting date and thanked CLC Moroz for his participation.

Miller then shared that the BBQ plans were well underway, and that she was seeking to update the CLC on plans since the last meeting and to obtain additional input on how to ensure the event's success. She gave an overview of the event location layout, booths, catering, portable washrooms and emergency

services onsite. She also previewed the event volunteer T-shirts and giveaway items (tote bags). As well, she spent time describing the information materials that would be available and shared with interested community members (for example, facility pamphlets, career handouts and information panels).

CLC Moroz shared his appreciation for the opportunity to learn more about the BBQ and suggested that we have information about how nuclear industry is helping to address climate change through clean power generation. Miller noted that some of our information panels have this information, but there was an opportunity to refresh them with up to date facts and figures.

Miller noted that there was an opportunity for a CLC member to act as a community guide and supervise one of the booths, answering questions about the CLC and membership application process. CLC Moroz volunteered for the role.

Miller reminded CLC Moroz that an Emergency Response Drill will be held at the Toronto facility on October 24, 2023. BWXT's Environment, Health and Safety staff develop the exercise with a mock-up scenario. The emergency response team does not know the details of this emergency until the day of the exercise in order to establish a more real-life situation. Toronto Fire Services and Toronto Police Service participate.

Miller asked whether CLC Moroz had any questions.

CLC Moroz did not have questions. He shared he looked forward to the BBQ later in the month.

Miller thanked him for attending and volunteering for the Toronto Community BBQ. She then adjourned the meeting.
